ROUTE INSTRUCTIONS

Please read the General Rules and Regulations carefully. Ask a rally worker for clarification if necessary. Drive safely and legally at all times. Watch for ALL types of road hazards. Heed ALL posted road signs. Be extremely mindful of unpredictable local traffic at all times. If you smoke, use your ashtray. Please don't litter. Please watch carefully for wild animals, especially around dawn. Watch for range cattle. Be very careful of children, animals and slow farm vehicles near isolated rural homes.

Please be aware of traffic behind you. Different classes run slightly different courses and may have to run at different speeds. It is a rule of ITN rally etiquette to let cars needing to run faster get past you at the first safe opportunity. Please remember this is not a question of who has the better car or who is the better driver. Furthermore, documented instances of deliberate blocking will receive a MAX penalty for that leg.

At Checkpoints, please get COMPLETELY out of the traffic lane when creeping. Last car in line MUST run their emergency flashers. Be sure to check your mirrors when pulling out to cross the hose. At Standoffs, you MUST park far enough OFF the road so that your door, when opened, will not extend into the traffic lane.

Unless otherwise stated, if there is one Standoff at a location, then 4.00 minutes have already been included in the leg time for you to sign in at Standoff and be given your information. At Restarts, any time for the Standoff(s) at that location is included before the Restart. All Passage Control signs in these Route Instructions are actual signs on course, located within 1.5 miles of the intended Inmarker location, unless otherwise specified.

All distances given in these Route Instructions, as well as in all information given to you on-course are "driving distance", i.e. the distance you actually have to drive on the roads shown on the Official Maps.

COURSE CONTROL 1 - START CONTROL

TRUE TIME: 0:00.00

LOCATION: East Parking Lot of Arroyo Burro Beach County Park,

2981 Cliff Drive, Santa Barbara, CA 93109 It is less than 90 miles to the next fuel.

You may not leave this Control until 9:00.00 PM plus your

car number in whole minutes.

COURSE

CONTROL: This control will be staffed.

LEG TIME: 00:28.00 TRUE TIME: 00:28.00

STANDOFF: Located on Cuervo Ave approximately 0.5 miles from its

intersection with Estrella Dr. Enter and leave in any

direction.

NOTE: Use Estrella Dr. to reach Cuervo Ave.

INMARKER: Is located neither north, south, east nor west of

CA SR 154. Enter and leave in the only direction possible.

SAFE ROADS: CA SR 154 is SAFE for all legs.

STANDOFF: Same location as Standoff 1

INMARKER: Is located neither north, south, east nor west of CA SR 154.

Enter heading generally southwest.

STANDOFF: Located on Foxen Canyon Rd, approximately 3.5 miles east

of its intersection with Palmer Rd. Enter heading generally southeast.

INMARKER: Located north of Foxen Canyon Rd. and south of

CA SR 166. Enter either eastbound or northbound...

BREAK: 8.00 minutes have been added to this leg for a splash of fuel

after Standoff 3 in Los Alamos. It is less than 150 miles until

the next fuel.

ODO CHECK: Alisos Canyon Rd. is 6.53 Official Miles from the edge of

Foxen Canyon Rd. to the STOP sign at US 101.

LEG TIME: 2:04.00 TRUE TIME: 4:44.00

STANDOFF: Located on CA SR 33, about 0.1 miles south of its

intersection with CA SR 166. Enter and leave in any direction.

INMARKER: Located on either Cuddy Valley Road, or Lockwood Valley

Road, within 10 miles of Lake of the Woods. Enter heading

toward Lake of the Woods.

MAP REFERENCE: 2, 3.

PASSAGE CONTROL:

There are similar signs on course, but only one with "ITN".



LOCATION: SW corner of the intersection of Old Ridge Route and

Pine Canyon Rd. Enter and leave in any direction.

Turn in at Standoff 5.

STANDOFF: Located on Munz Ranch Rd. (unnamed on Map), about

1.59 miles from its intersection with Elizabeth Lake Rd. (N2).

Enter heading northeast.

BREAK: 18.00 minutes have been included in this leg for a break in

Lebec or Gorman. It is less than 90 miles to the next break.

INMARKER: Located north of Rosamond Bl. and west of CA SR 14.

Enter southbound.

NOTE: This Passage Control sign is within 2 miles of the intended

Inmarker location.

STANDOFF: Located on E. Ave J, about 2.3 miles east of its intersection

with 200th St. E. Enter heading east.

BREAK: 5.00 minutes have been included on this leg for a quick stop

in Rosamond. There is a 24 hour Chevron on Rosamond Blvd. just east of CA SR 14. It is less than 120 miles to the

next break.

INMARKER: Located on Fort Tejon Rd. or Big Pines Hwy.

Enter westbound.

STANDOFF: Same location as Standoff 6.

INMARKER: Located east of US 395, south of CA SR 58, west of I-15,

and north of Air Expressway. Enter heading east.

MINIMUM SPEED: You must enter this Inmarker at a legal speed of at least

45 MPH.

LEG TIME: 1:36.00 TRUE TIME: 11:05.00

STANDOFF: Located on Calico Rd., about 0.37 miles north of its

intersection with Calico Blvd. Enter southbound.

RESTART: You may not leave this Standoff until 7:57.00 AM plus your

car number in whole minutes. (True Time = 10:57.00)

BREAK: 30.00 minutes have been included on this leg before Restart

for a break at I-15 and E. Main St. in Barstow. It is less than

90 miles to the next break.

INMARKER: Located on Calico Blvd. Enter heading toward the

easternmost of the two intersections of Calico Blvd. and

Calico Rd. Leave in any direction.


LOCATION: Harvard Rd., about 1.85 miles south of Yermo Rd.

CAUTION: There are a few potholes on National Trails Hwy.

its intersection with Amboy Rd., near the town of Amboy.

Enter and leave in any direction.

Turn in at Standoff 10, 11.

STANDOFF: Located in the parking lot of the Historic Kelso Depot, on

Kelso-Cima Rd., about 0.1 miles northeast of its intersection

with Kelbaker Rd. Enter and leave in any direction.

RESTART: You may not leave this Standoff until 10:23.00 AM plus your

car number in whole minutes. (True Time = 13:23.00)

BREAK: 5.00 minutes have been included on this leg for a break in

Ludlow. It is less than 170 miles to the next break. There

are restrooms at Standoff.

INMARKER: Located on Kelbaker Rd. or Cima Rd. Enter heading away

from the respective intersection with Kelso-Cima Rd.

MAP REFERENCE: 7, 8.

CONTROL: "Speed Limit 55" sign after "Radar Enforced" sign.


STANDOFF: Same location as Standoff 10.

INMARKER: Located on Morningstar Mine Rd. or Ivanpah Rd. If on

Morningstar Mine Rd., enter northbound. If on Ivanpah Rd., enter heading away from its intersection with Morningstar

Mine Rd. Leave in any direction.

MAP REFERENCE: 8, 9.



LEG TIME: 00:52.00 TRUE TIME: 15:02.00

STANDOFF: There is no Standoff for this leg.

BREAK: 5.00 minutes have been included in this leg for a splash of

fuel in Jean. It is less than 50 miles to the Finish.

INMARKER: Located on Las Vegas Blvd. S., exactly 8.00 miles from its

intersection with NV SR 161 in Jean. Enter northbound.

MINIMUM SPEED: You must enter this Checkpoint traveling at a legal speed of

45 MPH or above.
